

HOWICK PISTOL CLUB INCORPORATED (HPC) ACKNOWLEDGEMENTS OF RISKS, FULL RELEASE & INDEMNITY AGREEMENT

I agree and certify that I can speak, read and understand English as all forms, rules, instructions, conversations and commands are given in English.

1/ I hereby agree that I have voluntarily applied to enter in/or to observe shooting and other activities at the Howick Pistol Club shooting range (the" RANGE"). I further acknowledge and understand that "shooting and other activities" includes and all activities of any kind whatsoever in which I engage or observe while at the range, whether sponsored by HPC or not

2/ I acknowledge that shooting activities involve both known and unanticipated risks of and kind which could result in damage or destruction of property or emotional injury, of myself, my guest and/or other persons. The risks include but are not limited to being shot, inhalation or other harmful contact with lead or other contaminants, and being struck by flying or falling objects. I accept those risks and will be responsible for my safety and those in my party and all range participants as a part of being allowed to participate and or hold membership.

3/ I further acknowledge and understand that the nature and condition of the range facilities, premises and environment is such that both known and unanticipated hazards exist which create or contribute to both known and unanticipated risks inherent in entering onto the Range, in using the range facilities and in engaging and or observing any activities of any kind whatsoever while at the Range. I acknowledge and understand that the HPC has no duty to undertake first-aid to rescue operations or procedures in the event physical or emotional injuries occur. (FOR EMERGENCY CALL 111)

4/ I expressly agree to accept and assume any and all risks, on the Range and in entering onto the Range and in using Range facilities or equipment and in engaging or observing shooting and other activities at the Range. I agree to abide by all HPC by-laws and range rules and PNZ rules of gun safety, and to apply all gun safety rules to the maximum extent possible.

5/ I agree to assume the responsibility and liability for any wrong doings, negligent, reckless or criminal act or omission of myself or my guest. As a member I will ensure that each of my guests understands that the "Acknowledgement of Risks, Release & Indemnity Agreement" applies to them. This assumption of responsibilities constitutes that no actions can be taken by my family, heirs, associates and agents.

6/ I HEREBY RELEASE AND FOREVER DISCHARGE AND HOLD HARMLESS THE HPC ITS OFFICERS, DIRECTORS, AGENTS, EMPLOYEES, CONTRACTORS, VOLUNTEERS, GUESTS, HEIRS, EXECUTORS AND AFFILIATED INDIVIDUALS OR ORGANISATIONS OF THE HPC FROM AND AGAINST ANY AND ALL CLAIMS, DEMANDS, DAMAGES, EXPENSES, CAUSE OF ACTION, ATTACHMENTS OF PROPERTY, OR LIABILITY OF ANY KIND WHATSOEVER, FOR INJURY OR DEATH RESULTING FROM MY OR MY GUESTS ENTERING ONTO THE RANGE, FROM USING RANGE FACILITIES, OR EQUIPMENT, OR ENGAGING IN OR OBSERVING SHOOTING AND OTHER ACTIVITIES AT THE RANGE, EVEN IF SUCH CLAIMS, DEMANDS, DAMAGES, EXPENSES, CAUSE OF ACTION, OR LIABILITY RESULT PARTIALLY OR WHOLLY FROM ANY ACT OR ACTS OF ANY PERSON, INCLUDING ANY NEGLIGENT ACTS OR OMISSIONS.

7/ I understand that amateur or commercial still, photos, video and/or motion picture photography may occur during my presence on the Range and that I may be incidentally included in such photography. Should I wish to be excluded from such photography, I understand that it is my responsibility to be aware of photographic activity and remove myself from the area or event being photographed. Absent such action on my part, I hereby grant the HPC its sponsors and beneficiaries, the right to use my photographic image in a promotion of the HPC or shooting sports in general, in accordance with accepted journalistic practice.

8/ I further acknowledge and agree I am a member and that it is my understanding and intent that this agreement and any signed written amendments or modifications to it, shall remain in full force and effect from the date of execution until I sign another agreement and shall be applicable to each and every occasion that I or any guest of mine enter the Range, use equipment, or engage in shooting and other activities at the range.
